## 概要

### 最終發售價

發售價已釐定為每股發售股份0.41港元(不包括1%經紀佣金、0.0027%證監會交易徵費及0.005%聯交所交易費)，即招股章程所載的發售價範圍的中位數。

### 股份發售所得款項淨額

按發售價每股發售股份0.41港元計算，經扣除相關包銷佣金及與股份發售有關的估計開支後，本公司將從股份發售收取的所得款項淨額估計約為76.5百萬港元。本公司擬按本公告「股份發售所得款項淨額」一節及招股章程「未來計劃及所得款項用途」一節所載的用途應用有關所得款項淨額。

### 公開發售項下的申請
